RESERVE IN TERMS OF SECTION 23(1) OF THE NATIONAL ENVIRONMENTAL
MANAGEMENT: PROTECTED AREAS ACT, 2003**

I, Siboniso Armstrong Duma, in my capacity as Member of the KwaZulu-Natal Provincial Executive Council for Economic Development, Tourism and Environmental Affairs, and under powers vested in me by section 23(1)(a)(i) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003) ("the Act"), hereby declare that –

- (a) subsequent to consultation with the relevant parties as contemplated in section 32 of the Act;
- (b) subsequent to the publication of Notice Number 593 of 19 October 2023 in Provincial Gazette 2608, and an advert in two national newspapers, in which my intention to declare the Northern Drakensberg Nature Reserve was duly published in accordance with the requirements of section 33(1) of the Act;
- (c) subsequent to agreements being concluded with the landowners in accordance with section 23(3) of the Act; and
- (d) with effect from the date of publication of this Notice,

the property described in the Schedule hereto is a Nature Reserve, known as the Northern Drakensberg Nature Reserve, as contemplated in sections 23(1)(a)(i) and section 23(1)(b) of the Act.
